+ Assessing heritage significance

Understanding the importance of a heritage asset and the value of its historic fabric is a crucial first step in exploring proposals that may involve alteration, extension or demolition. Through the assessment of architectural evidence and historic fabric, reviewing documentary sources and material analysis, H+R have the skills to identify and effectively describe the architectural and historic interests of heritage assets. H+R services include preparing statements of significance, heritage impact assessments and heritage statements.

Historic building analysis and recording

Historic building analysis is an important step in assessing significance and can also be a condition requirement where planning permission and listed building consent is granted for alteration, extension or demolition. It can be used to understand the development of buildings, to inform schemes of alteration and repair, document damage or loss, discharge planning conditions and inform wider research.

Our team of surveyors can provide different levels of building analysis and recording depending on client need, ranging from basic visual assessment, simple drawings and preparation of photographic records to more sophisticated metric survey. H+R are able to comply with Historic England's prescribed levels of recording.







+ Condition and maintenance surveys

H+R undertake condition surveys to meet a range of client requirements including pre-purchase surveys, condition surveys, buildings at risk assessments, Church of England guinguennial inspections, environmental or building performance surveys, schedules of dilapidation and preventive maintenance inspections. These types of survey establish the condition of a building or structure at a particular time and can be used to inform and prioritise remedial action. This information can be useful to help potential purchasers appreciate repair requirements, understand the implications of defects, identify repair and maintenance liabilities and develop planned preventive maintenance strategies with schedules of prioritised work.

Defect diagnosis and material analysis

Building defects and processes of decay often require detailed investigation to understand the underlying causes, assess how matters may develop over time and inform appropriate remedial action. Site and laboratory tests can also be used to identify materials, understand decay processes and assist in designing suitable solutions. H+R have long-standing experience of understanding and remedying building defects and failures with practical and cost-effective solutions.
